Artist Bio Example



With over 200 successful exhibitions under his belt, Eric Glover is a seasoned professional artist. He focuses on the sensual nature of art, aiming to depict the complications of life through a combination of color, texture, and symbolism. His exhibitions have been housed in institutions such as the Smithsonian, the Museum of Modern Art, the Escher Memorial, and several academic universities worldwide. His work has been cited and referenced in numerous works of music and cinema, such as the film Grey is the Shadows, which released in 2012.

Eric Glover is a graduate of the National Art Institute in Brooklyn, New York. He started producing sculpted works of art as a freshman, where he created the piece Botticelli's Revival (on display in the Folger Gallery). He then created several art pieces for various local businesses, which recommended his pieces to be published in the city paper. Soon, Eric began working for the Reshler Gallery, creating pieces for the Contemporary Art exhibit.

Eric Glover has also given talks at various academic institutions worldwide, where he speaks on the role of art in human life. He has been invited to speak on a TED talk in late 2015. Additionally, he is a lecturer at Oxford University, where he teaches a short 4-week course on the art of aesthetics. One of his protégés is Mark Vieber, known for his attention to detail in creating miniature depictions of everyday life. Eric and Mark together have created a foundation called Painting Eyes, which reaches out to underserved communities and encourages artistic foundations in young children. The organization has now expanded to include several cities, such as Brooklyn and Detroit City. Eric and Mark hope to be able to expand internationally by the end of 2020.

Works can be for sale or not for sale (NFS). All sales will be conducted through FCA, with 30% of sale price retained as commission by FCA. Please allow up to 3 weeks after the end of the show for all sales to be reconciled and checks to be mailed out.

PUBLICITY

Submission of work for exhibition grants permission for the photographing or use of artwork images for publicity purposes.

LIABILITY

FCA strongly encourages artists to carry their own insurance. all reasonable care will be taken in the handling of works; however, FCA is not responsible for loss or damage, however caused. Catastrophic loss insurance does apply.
